## CONSTITUTION OF NATIONAL YOGA FEDERATION OF INDIA AS ON 1<sup>ST</sup> JANUARY, 2017

1. **NAME:** The name of the Organization shall be National Yoga Federation of India-NYFI.
2. **REGISTRATION:** The NYFI registered under the INDIAN TRUSTS ACT OF 1882, Govt of India
3. **AFFILIATION:** The NYFI affiliated to the Indian Non-Olympic Association, Asian Yoga Committee, and International Yoga Committee.
4. **HEADQUARTERS:** The office of the NYFI shall be at Utter Pradesh, the place of residence of the President, National Yoga Federation of India-NYFI.
5. **JURISDICTION:** The jurisdiction of the NYFI at Lucknow, Utter Pradesh.
6. **AIMS AND OBJECTS**
  - a) To promote Yoga Education internationally and take whatever measures are necessary to this end.
  - b) To represent the interests of its members at International level with regard to the authorities, other educational Committees, the mass media and the public, in as far as this is not left up to the members.
  - c) To promote educational contact between all Universities, Yoga institutions, Yoga authorities, and individuals and to promote yoga, yoga championship, international/national conferences etc.
  - d) NYFI will support all country rules and regulation based on the requirement.
  - e) To encourage all yoga individuals, Universities, educational institutions, educational authorities, and yoga institutions can connect in professional communication in the field of flexible yoga sport.
7. **FINANCEIAL YEAR:** The financial year of NYFI shall be from 1<sup>st</sup> April to 31<sup>st</sup> of March of every year.
8. **MEMBERSHIP:** The membership of the NYFI confine to State Yoga Associations.
9. **FEE AND MEMBERSHIP:** The fee for being state in-charge is:-
  - a) Annual Affiliation fee Rs.3,500/- to be deposited in the name if “**International Yoga Committee**”.
  - b) NYFI certified player registration fee Rs.100/- for each player.
  - c) National Yoga Referee Examination/Up-gradation fee Rs.1500/-.
  - d) Registration of Zonal/National/State/District Yoga Championship is Rs.5000/-.
  - e) Note:- **The Annual Membership fees shall be payable by 31<sup>st</sup> March of every year.**
10. **OFFICE BEARERS:** The following shall be the office bearers of the Federation, who shall be elected for a term of four years:-

a) National President	:	One
b) National Vice Presidents	:	Seven
c) National Secretary General	:	One
d) State In-Charge	:	One
e) National Joint Secretaries	:	Six
f) National Treasurer	:	One
g) National Executive Members	:	Twenty

**13. RESIGNATION:** Any member, who desires to resign from the Federation, shall give in writing to the President or Secretary General at least one month in advance.

**14. RULES AND REGULATIONS:** NYFI will follow rules of International Yoga Committee-IYC.

**15. AWARD OF CERTIFICATES AND MEDALS:**

- a) National Event/Zonal Event Medals and Merit Certificates will be awarded by the National Yoga Federation of India.
- b) Referee Certification will be awarded by the National Yoga Federation of India. (Note: State Association will not have any rights to provide referee certifications).
